#### Terms & Conditions

- 1) OCBC Cycle Virtual Ride 2021 (“Event”) is owned by OCBC Bank (“Event Owner”) who is also the Title Sponsor and organised by PICH Event Management (“Event Organiser”). This “post-Event Survey” lucky draw (the “**Lucky Draw**”) is organised by the Event Owner.

  - a) Be a registered participant of OCBC Cycle Virtual Ride 2021 (or parent of the Mighty Savers® Kids Virtual Ride participant),
  - b) Have your ride details approved by the Event Organiser, and

- 5) All winners will be notified by email or phone, as per the email addresses or contact numbers provided in the Event registration forms.
- 6) The Event Owner shall have the final say regarding the lucky draw results. The Event Owner’s decisions on all matters relating to the Lucky Draw shall be final and binding on all participants. No correspondence or appeal shall be entertained by the Event Owner. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Lucky Draw, these terms and conditions shall prevail.
- 7) All prizes are non-transferrable, non-assignable, non-exchangeable, and not saleable for cash, credits or kind. The Event Owner shall have the right to replace or substitute the prizes with an item of similar value.

- 9) Employees of the Event Owner and the Event Organiser are not eligible to participate in this Lucky Draw.

- 11) OCBC Bank reserves the right to terminate, postpone or suspend the Lucky Draw and/or add to, delete, change or vary these terms and conditions at any time or from time to time without notice.
- 12) The Event Owner reserves the right to claw-back and reclaim from any participant any prize, or the equivalent value of the prize, if that participant is subsequently disqualified or discovered to be ineligible to participate in the Lucky Draw or to receive the Prize. The Event Owner reserves the right to (i) forfeit or withdraw any prize at any time; or (ii) (where the prize has been redeemed) claw-back the prize or request the relevant participant to repay to or compensate the Event Owner the value of the prize at any time, and the Event Owner shall have the right to debit the value of the prize plus any goods and services tax or such other amount as it deems fit from any account(s) that the participant holds with the Event Owner.
